## THE LAW SCHOOL

In spite of the increase in entrance requirements for the Law School from two to three years of college work, effective this fall, the first year class numbers 67 as compared with 52 last year. This represents not only the largest but the best prepared entering class in the history of the School, for of the 67, 31 have college degrees, 6 have had four years of college work, 19 have had three years, 7 have had two years, and 4 are special students. The seven with two years of preparation are those entering under a clause in the new trustees' regulation providing that students who had entered the University prior to last January should not be subject to the change. The total enrollment aggregates 114 as compared with 113 a year ago. Of these, 65 have college degrees. There are 26 in the second year class, and 21 in the third year class.

New courses this year include Administration of Debtors' Estates, by Professor Hanft, and Legislation by Dean Van Hecke. Pro-
