## THE LAW SCHOOL

The attendance in the Law School is the highest in the last ten years. One hundred and twenty-four law students are enrolled, as compared with 114 at this time last year and the previous high of 120 in the fall of 1929. Fifty-seven are first-year students, 42 are in the second year class, one is from the Graduate School and 24 are seniors. Twelve of the seniors pass the state bar examination in August but have returned to complete their studies and to receive the University law degree. All of the students in the Law School are from North Carolina except eleven, and these eleven come from Connecticut, Massachusetts, New Jersey, New York, Pennsylvania, West Virginia, and Virginia. More than half of the students in the Law School, 67 to be exact, have earned their college degrees. The preparation of the first-year class is indicated by the following figures. Of
