THE LAW SCHOOL

Registration for the fall semester of the Law School of the University of North Carolina is sixteen, as compared with twelve at this time a year ago. There are indications that the number of veterans returning to study law will increase during the coming year and that a gradual return to normal enrollment will take place. The Law School will meet the needs of law students as long as the University and the State of North Carolina continue present policies as to legal education.

The following members of the faculty are absent on leave: Professor Henry P. Brandis, Lieutenant (j.g.), United States Naval Reserve; Professor John P. Dalzell, Assistant to the Solicitor, Department of the Interior, Washington, D. C.; Professor Frank W. Hanft, Major, U. S. Army, Civil Affairs Officer attached to headquarters of the Ninth Air Force, France; Professor M. T. Van Hecke, Southeastern Regional Director, National War Labor Board, Atlanta, Georgia.

Professor Benjamin F. Small who gave the course in Domestic Relations during the summer session, has joined the faculty for the present school year. Mr. Small is a graduate of the University of Indiana Law School and, during 1943-1944, was a member of the faculty of the Law School of the University of Kansas City.

During the summer session of 1944 at the Law School of the University of North Carolina, Judge J. Warren Madden, of the United States Court of Claims, gave the course in Labor Law. Professor M. S. Breckenridge served as a visiting professor in the School of Law at George Washington University during the second term of the summer session, teaching the subject of Agency.

Dean Robert H. Wettach has been appointed chairman of a state-wide commission to revise the insurance laws of North Carolina.

The executives of the editorial staff of the NORTH CAROLINA LAW REVIEW for 1944-1945 are: Cecil J. Hill, editor-in-chief, James G. Hudson, Jr. and Charles F. Coira, Jr., associate editors. They are likewise the recipients of the faculty research assistantships for the current year.

William A. Johnson, who was editor-in-chief of the LAW REVIEW last year, was elected in the spring to the honorary Law School society of the Order of the Coif.
